## Special Educational Needs and Disabilities - Frequently asked questions

Question	School Response
How do you identify Special Educational Learning Needs?	<ul> <li>When pupils have identified SEND (Special Educational Needs and Disabilities) before they start at Crossflatts Primary School, we work with the adults who already know them and use the information already available to identify what their specific needs will be in our school setting.</li> <li>The progress of all pupils is monitored regularly.</li> <li>If you inform us that you think your child has a Special Educational Need or Disability, we will discuss this with you and look at what assessments or provision may be required– we will share with you what we find, agree with you what we will do next and what you can do to help your child.</li> <li>If our teachers think your child may have a Special Educational Need or Disability, this may be because they are not making the progress expected. We will observe them, and carry out further assessments to pinpoint what is causing difficulty (what is happening and why).</li> <li>The specialist SENCO and/or Co-ordinator of Learning may work with your child at this point in order to complete a range of assessments to highlight your child's strengths and possible areas of weakness so that support can be carefully targeted to their needs.</li> </ul>
How could my child get help in school?	<ul> <li>Every child in school will get support that is specific to their individual needs. This will provided by the class teacher and may also involve other staff in the school.</li> <li>Staff who will visit the school from the Local Authority central services; such as the ASD Outreach Team or Learning Support Services (Refer to end - Other Agencies)</li> <li>Staff who visit from outside agencies such as the Speech and Language Therapy (SALT) Service.</li> </ul>
How is extra support allocated to children and how do they move between the different ranges?	<ul> <li>The school budget, received from Bradford LA, includes money for supporting children with SEND.</li> <li>The Head Teacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of needs in the school.</li> <li>The Head Teacher and the SENCO discuss all the information they have about SEND in the school, including         <ul> <li>the children receiving additional support</li> <li>the children needing extra support</li> <li>the children who have been identified as not making as much progress as would be expected and decide what resources/training and support is needed.</li> </ul> </li> </ul>
How can I let the school know I am concerned about my child's progress ?	<ul> <li>If you have concerns about your child's progress you should speak to your child's Teacher initially.</li> <li>The concerns may need referring to the SENCO if your child is still not making progress.</li> <li>If you continue to feel that your child is still not making progress you should speak to the Head teacher</li> </ul>
How will the school let me know if they have any concerns about my child's learning in school?	<ul> <li>When a teacher has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher will raise this with the SENCO.</li> <li>Regular pupil progress reviews and subsequently meetings between the Head, Deputy, SENCO assistant and class teachers take place to ensure all children are making progress.</li> <li>If your child is identified as not making expected progress, the school will set up a meeting to discuss this with you in more detail and listen to any concerns you may have too.</li> </ul>

Question	School Response
How will the teaching be adapted for my child with learning needs (SEND)?	<ul> <li>Teachers plan lessons according to the specific needs of all groups of children in their class, and will ensure that your child's needs are met. All teachers are provided with information on the needs of individual pupils, so that they can plan the learning within our curriculum to ensure that all pupils make at least expected progress.</li> <li>Differentiation is planned for groups and individuals according to need: for example, for a child who has Speech, Language and Communication Needs (SLCN), teachers will use simplified language and/or pictures to support them to understand new vocabulary.</li> <li>Learning Support Assistants may also support with your child's learning.</li> <li>Specific appropriate resources and strategies will be used to support your child individually and/or in groups.</li> <li>Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs.</li> </ul>
How will school support my child?	<ul> <li>When the school identifies the need for additional intervention to enable a pupil to make expected progress, the parents/carers will be informed of the planned support and may be invited to a meeting at the school to discuss this further. If the pupil meets the criteria for special educational needs or disabilities (SEND), a provision map will be created, detailing the support the pupil will receive using the Bradford Ranges 1, 2 and 3; a copy of this will be provided to parents / Carers.</li> <li>We will monitor the progress of all children receiving additional support to ensure that the provision we have put in place is having impact.</li> <li>Governors are responsible for monitoring the effectiveness of the provision in place for pupils identified with SEND and they will receive a report from the SENCO on the progress of pupils with SEND</li> </ul>
How will we measure the progress of your child in school?	<ul> <li>Your child's progress is continually monitored by his/ her teachers and the Leadership Team.</li> <li>His / Her progress is reviewed formally every term and an EYFS development in months and a National Curriculum level in KS1 &amp; KS2 is given in reading, writing, maths and science (+ Sp &amp; L in Y1/2).</li> <li>If your child is not at level 1, your child will be assessed using another scale of levels that assess attainment up to Level 1. These are called 'P levels'.</li> <li>At the end of Reception, Key Stage 1 and 2 the school is required to report attainment levels for your child, along with the results of the Y1 Phonic screening. The results are published nationally.</li> <li>The progress of children with a statement of SEND/ EHC Plan (at Bradford's Range 4 to 7) is formally reviewed at an Annual Review with all adults involved with the child's education.</li> <li>The Learning Co-ordinator and/or SENCO will also check that your child is making good progress within any individual work and in any group that they take part in.</li> </ul>
How will both you and I know how my child is doing and how will you help me to support my child's development?	<ul> <li>Termly reports / Parents' Evenings give all parents and carers regular feedback on their child's up to date academic progress, english and maths targets and any behavioural, emotional or social difficulties. All parents/ carers who have children on the Special Educational Needs list wherever possible receive an extended appointment to allow time to review provision with the SENCO.</li> <li>When appropriate, parents/carers may be contacted mid-term to discuss the support that the school are providing and how they can help their child at home: this may be a phone call or a meeting. Pupils' views will be obtained and they may attend all or part of any meeting, when appropriate.</li> <li>Parents/carers are welcome to come into school or contact the school office at any time to make an appointment to see a member of staff about their child's leaning.</li> </ul>

Question	School Response
What support will there be for my child's/young person's overall well-being?	<ul> <li>The well-being of all of our pupils is our primary concern at Crossflatts Primary School. They are supported with their social and emotional development throughout the school day, through the curriculum and extra-curricular activities. Personal, Social and Health Education (PSHE) and Social and Emotional Aspects of Learning (SEAL) are integral to our curriculum and are also taught explicitly on a weekly basis.</li> <li>If a pupil has a medical need, then a detailed Care Plan is compiled with support from the School Nurse in consultation with parents / carers. These are discussed with all staff who are involved with the pupil.</li> <li>Where necessary and in agreement with parents/ carers prescribed medicines are administerd in school, but only where a signed medicine consent form is in place to ensure the safety of both child and staff member.</li> <li>Additional support from specialist staff is arranged as needed for individual pupils, both in and out of the classroom; a tailored personal plan may be put in place for pupils with the highest need.</li> <li>Our Behaviour Policy; which includes guidance on expectations and sanctions is fully understood and in place by all staff.</li> <li>We regularly monitor attendance, support pupils returning to school after absence and take the necessary actions to prevent prolonged unauthorised absence.</li> <li>Relevant staff are trained to support medical needs and in some cases a majority of staff receive training (e.g Epipen/Team teach).</li> <li>Pupils' views are sought through School Council and class assemblies.</li> </ul>
What specialist services and expertise are available at or accessed by the	<ul> <li>All external partners we work with are vetted in terms of safe guarding and when buying in additional services we monitor the impact of any intervention against cost, to ensure value for money.</li> <li>At appropriate times, schools will contact and seek advice from a range of Educational Outside Agencies, Outreach Services and Health professionals (refer to list at end of this document).</li> <li>We work with Social Services, Bradford Family Support and Community Police.</li> <li>We also have a Parent Involvement Worker to support families.</li> </ul>
How will my child What support do we have for be included in you as a parent/ carer of a activities outside child with an SEND? the classroom?	<ul> <li>Progress through partnerships is crucial to the holistic development of your child. We encourage regular time for you to talk to your child's teachers, so we can share knowledge and ensure that appropriate support for your child both at home and school, is working in both places.</li> <li>The SENCO is available to meet with you to discuss your child's progress or any concerns/worries you may have.</li> <li>All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report. The SENCO will also meet or discuss any new assessments and ideas suggested by outside agencies for your child.</li> <li>Homework will be adjusted as needed to your child's individual needs.</li> <li>We actively try to ensure that all our extra-curricular activities, including residentials, are adapted for children's specific needs. Risk assessments are carried out and procedures are put in place to enable all children to participate, where possible. However, if it is deemed that an intensive level of one to one support is required, a parent / carer may be asked to accompany their child during the activity or alternative provision made.</li> </ul>
How have we made sure Crossflatts Primary School is accessible to children with SEN?	<ul> <li>As a school we are happy to discuss individual access requirements. Facilities we have at present include: <ul> <li>Lift</li> <li>Ramps</li> <li>Disabled toilets</li> <li>Wide doors and corridors</li> </ul> </li> <li>We ensure that equipment used is accessible to all children regardless of their needs.</li> <li>Visual prompts are used across the school to support learning. We use Visual timetables throughout school.</li> </ul>

e support your child's transition(either when aving this school to another Year)?	<ul> <li>School Response</li> <li>We recognise that 'moving on' can be difficult, especially for a child with SEND. We personalise our transition to ensure that these are as smooth as possible.</li> <li>If your child is moving to another school: <ul> <li>We will contact the school SENCO and ensure he/she knows about any special arrangements or support that need to be made for your child.</li> <li>The SENCO will arrange additional visits to new schools for your child and personalised resources to support transition may be used.</li> <li>Staff from the receiving school may also visit to see your child in their current setting</li> <li>We will make sure that all records about your child are passed on as soon as possible.</li> <li>Teachers will attend any appropriate training around transition arrangements.</li> </ul> </li> <li>When moving years in school: <ul> <li>Information will be shared with new teachers and time given to discuss each individual child.</li> <li>Some children will develop their own transition passports which show key staff, routines and areas in the classroom that can be taken home and discussed during the summer holidays.</li> <li>Some children will put together information about 'Who Am I', to help the new teacher get to know the whole child.</li> </ul> </li> </ul>

	Class teacher input via excellent targeted classroom teaching also known as Quality First Teaching.	<ul> <li>Ensuring that the teacher has the highest possible expectations for your child and all pupils in their class.</li> <li>Ensuring that all teaching is based on building on what your child already knows, can do and can understand, using the accelerated learning phases.</li> <li>Implementing different teaching strategies, so that your child is fully involved in his/her learning.</li> <li>Establishing specific strategies (which may be suggested by the SENCO or outside staff) to support your child to learn.</li> </ul>	All children in school as a part of outstanding classroom practice.
What are the different types of support available for children with SEN in this school?	<ul> <li>Specific group work within a smaller group of children. This group may be</li> <li>Run in the classroom or outside.</li> <li>Run by a member of staff who has had training to lead the intervention.</li> </ul>	<ul> <li>Through continual formative assessment your our child's teacher may decide that your child has gaps in their understanding/learning and needs some extra support to help them make the best possible progress.</li> <li>A teacher, Learning Support Assistant or outside professional (like a Speech and Language Therapist) may run small group sessions using the teacher's information either in a small group or within the classroom setting.</li> </ul>	Any child who has specific gaps in their understanding of a subject/area of learning. Children maybe be at the stage of the SEN Code of Practice called <b>Bradford</b> <b>Range 1,2 (previously</b> <b>School Action)</b> , which means they have been identified by the class teacher as needing some extra support.
	Specialist groups run by or in partnership with outside agencies	<ul> <li>Your child will have been identified by the class teacher/Co-ordinator of Learning/SENCO (or you may have raised concerns) as needing further specialist input instead of or in addition to outstanding class room teaching and intervention groups.</li> <li>You will be asked to come to a meeting to discuss your child's progress and help plan possible ways forward.</li> <li>You may be asked to give your permission for the school to refer your child to a specialist professional e.g a Speech and Language Therapist or Educational Psychologist. This will help the school and yourself gain a better understanding of your child's particular needs and be able to support them more effectively.</li> <li>The specialist professional will work with your child to understand their needs and make recommendations, which may include:         <ul> <li>Making changes to the way your child is supported in class e.g some individual support or changing some aspects of teaching to support them better</li> <li>Support to set clearer targets which will include their specific expertise for teachers to implement</li> <li>A group run by school staff under the guidance of the outside professional e.g a social skills group</li> <li>A group or individual support in school. They will tell you how the support will be used and what strategies will be put in place.</li> </ul> </li> </ul>	Children with specific barriers to learning that cannot be overcome through Quality First Teaching and intervention groups. Stage of SEN Code of Practice: Bradford Range 2, 3 (previously School Action Plus)which means they have been identified by the class teacher/SENCO as needing some additional specialist support in school from a professional outside the school.

Specified Individual support for your child of more than 20 hours in school.	•	The school (or you) can request that the Local Authority carry out a statutory assessment of your child's needs. This is a legal process and you can find more details about this in the Bradford Local Offer. After the school have sent in the request to the Local Authority (with comprehensive information about your child, including some from you), they will decide whether they think your child's needs (as described in the paperwork provided), seem complex enough to need a statutory assessment.
